Every entry at a recognized competition shall constitute an agreement and affirmation that all participants (which include without limitation, the owner, leasee, trainer, manager, agent, coach, driver, rider, handler and the horse), for themselves, their principals, representatives, employees and agents: (1) shall be subject to the constitution and rules of the Association and the local rules of the competition; (2) represent that every horse, rider, driver and handler is eligible as entered; (3) agree to be bound by the constitution and rules of the CESHs/CBHSA and the competition, and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold the competition, the CESHs/CBHSA, their officials, directors and employees harmless for any action taken; (4) agree that as a condition of entry, they authorize the CESHs/CBHSA and/or our management to market, transfer, assign or otherwise make use of any photographs, likenesses, films, broadcasts, cablecasts, audiotapes taken of the horse(s) and participant(s) while on the grounds, incident to, or in transit between the stabling facility and the event site, in any way they see fit for the promotion, coverage or benefit of the event, sport, or the CESHs/CBHSA, without compensation to any of them, so long as the use neither jeopardizes amateur status nor endorses a specific product or service, and hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to invasion of privacy, right of publicity, or to misappropriation; and (5) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold the CESHs/CBHSA, the competition, and their officials, directors, employers and agents harmless from and against all claims including for any injury or loss suffered during or in connection with competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of the CESHs/CBHSA or the competition. The construction and application of CESHs/CBHSA rules are governed by the State of New York, and any action instituted against the CESHs/CBHSA must be filed in New York State. See Article 1502.5.

**CESHs Rule XVIII.7** Anyone having an outstanding indebtedness to the Association or any member show shall not be in good standing until the indebtedness is satisfied. A person must be in good standing with the CESHs before being allowed to show or register an animal. There will be a \$25.00 returned check fee.
